

INDEPENDENT LIMITED ASSURANCE STATEMENT



To: The Stakeholders of Kellogg Company

Introduction and objectives of work

Apex Companies LLC (Apex) has been engaged to conduct independent third party limited assurance of global food loss and waste data by the Kellogg Company. This assurance statement applies to the Subject Matter included within the scope of work described below.

This information and its presentation are the sole responsibility of the management of Kellogg Company. Our sole responsibility was to provide independent assurance on the accuracy of the Subject Matter.

Scope of work

The scope of our work was limited to assurance over food loss and waste (FLW) data for the period January 1, 2021 to December 31, 2021 (the 'Subject Matter'). Our assurance does not extend to any other information reported by Kellogg Company.

Reporting Boundaries

The following are the boundaries used by Kellogg Company for reporting sustainability data:

- Food Category: Manufactured Foods under Operational Control
- Lifecycle Stage: Manufacturing Operations
- Geography: Worldwide Operations
- Organization: Kellogg Company

Limitations and Exclusions

Excluded from the scope of our work is any assurance of information relating to:

- Activities outside the defined assurance period;

This limited assurance engagement relies on a risk based selected sample of sustainability data and the associated limitations that this entails. The reliability of the reported data is dependent on the accuracy of metering and other production measurement arrangements employed at site level, not addressed as part of this assurance. This independent statement should not be relied upon to detect all errors, omissions or misstatements that may exist.

Responsibilities

This preparation and presentation of the FLW data are the sole responsibility of the management of Kellogg Company.

Apex was not involved in the development, tracking, or reporting of the FLW data. Our responsibilities were to:

- obtain limited assurance about whether the Subject Matter has been prepared in accordance with the Reporting Criteria;
- form an independent conclusion based on the assurance procedures performed and evidence obtained; and
- report our conclusions to the Stakeholders of Kellogg Company.

Assessment Standards

- We performed our work in accordance with Apex's standard procedures and guidelines for external Assurance of Sustainability Reports and International Standard on Assurance Engagements (ISAE) 3000 Revised, Assurance Engagements Other than Audits or Reviews of Historical Financial Information (effective for assurance reports dated on or after Dec. 15, 2015), issued by the International Auditing and Assurance Standards Board. A materiality threshold of ± 5 -percent was set for the assurance process.

Summary of Assurance Process

As part of our independent assurance, our work included:

1. Assessing the appropriateness of the Reporting Criteria for the Subject Matter;
2. Conducting interviews with relevant personnel of Kellogg Company;
3. Virtual site visits to Jackson Manufacturing Facility – KNA, Memphis Manufacturing Facility – KNA and Rossville Manufacturing Facility – KNA;
4. Reviewing the data collection and consolidation processes used to compile Subject Matter, including assessing assumptions made, and the data scope and reporting boundaries;
5. Reviewing documentary evidence provided by Kellogg Company;
6. Agreeing a selection of the Subject Matter to the corresponding source documentation;
7. Reviewing Kellogg Company systems for quantitative data aggregation and analysis; and
8. Assessing the disclosure and presentation of the Subject Matter to ensure consistency with assured information.

Reporting Criteria

- The Subject Matter needs to be read and understood together with the World Resources Institute (WRI)/The Consumer Goods Forum (CGF)/ Food and Agriculture Organization of the United Nations (FAO)/FUSIONS project/United Nations Environment Programme (UNEP)/WRAP (The Waste and Resources Action Programme)/World Business Council for Sustainable Development (WBCSD) *Food Loss and Waste Accounting and Reporting Standard Version 1*.
