### Competition Terms and Conditions

#### Competition Schedule

<b>Entry Requirements</b>	Competition is open to Australian residents who are aged 18 years or over and must hold a valid Australian personal PayPal account in good standing (for example, it is not restricted or limited in any way, and does not have a negative balance) at all relevant times, excluding employees and contractors of the Promoter and their family members, and any agencies or companies associated with the management of this Competition.

The comment does not need to include anything else.</li> <li>- Send to PayPal Instagram Account @PayPalAU the Entrant's PayPal Account email address via Direct Message on Instagram.</li> </ul> <p>Weekly winners for each Round who submitted eligible entries during the submission period for each Round outlined above will be randomly selected and announced following the notification process set out in the Notification Method section below.</p> <p>The computerised random draw of Weekly winners for each Round will be conducted by MDSA at Level 17, 40 Mount Street, North Sydney NSW 2060 on the dates and time included in Competition Period section of these Terms &amp; Conditions</p>
<b>Maximum Number of Entries</b>	Unlimited entries can be submitted. However, each Entrant is only eligible to win one Prize under the entire Competition (except for residents of South Australia).

## ***Competition Terms and Conditions***

1. These terms and conditions of Entry must be read together with the Schedule outlined in the table above and together constitute your agreement with the Promoter in relation to your participation in the Competition (**Terms and Conditions**). By entering, Entrants accept and agree to be bound by these Terms and Conditions. The Competition is in no way sponsored, endorsed or administered by, or associated with any of the social media platforms (unless stated otherwise), including TikTok, Facebook or Instagram.
2. Entry is only open to Australian residents who comply with the Entry Requirements.
3. The Competition will be run during the Competition Period and will be administered by the Promoter together with Edelman Australia.
